Introduction

The use of information and communication technology is an integral part of the national curriculum and is a key skill for everyday life. Comupters, tablets, programmable robots, digital and video cameras are a few of the tools that can be used to acquire, organise, store, maniupulate, interpret, communicate and present information. We recognise that pupils are entitled to quality hardware and software and a structured and progressive approach to the learning of the skills needed to enable them to use if effectively.

Aims

- Provide a relevant, challenging and enjoyable curriculum for ICT and computing for all pupils
- Meet the requirements of the national curriculum programmes of study for computing.
- Use computing as a tool to enhance learning throughout the curriculum.
- To respond to new developments in technology.
- To equip pupils with the confidence and capability to use computing throughout their later life.
- To enhance learning in other areas of the curriculum using computing.
- To develop the understanding of how to use computing safely and responsible.

The national curriculum for computing aims to ensure that all pupils:

- Can understand and apply the fundamental principles of computer science, including logic, algorithms, data representation, and communication.
- Can analyse problems in computational terms, and have repeated practical experience of writing computer programs in order to solve such problems.
- Can evaluate and apply information technology, including new or unfamiliar technologies, analytically to solve problems.
- Are responsible, competent, confident and creative users of information and communication technology.

Rationale

The school believes the ICT and computing:

- Gives pupils immediate access to a rich source of materials.
- Can present information in new ways which help pupils understand access and use it more readily.
- Can motivate and enthuse pupils
- Can help pupils focus and concentrate.
- Offers potential for effective group working.
- Has the flexibility to meet the individual needs and abilities of each pupil.

Objectives

Early years

It is important in the foundation stage to age five, children have a broad, play-based experience of ICT in a range of contexts, including outdoor play. Computing is not just about computers. Early Years learning environments should feature ICT scenarios based on experience in the real world, such as in role play. Children gain confidence, control and language skills through opportunities to explore using not-computer based resources. Recording devices can support children to develop their communication skills. This is particularly useful with children who have English as an additional language.

By the end of key stage 1 pupils should be taught to:

- Understand what algorithms are, how they are implemented as programs on digital devices, and that programs execute by following a sequence of instructions.
- Write and test simple programs.
- Use logical reasoning to predict the behaviour of simple programs.
- Organise, store, manipulate and retrieve data in a range of digital formats.
- Communicate safely and respectfully online, keeping personal information private, and recognise common uses of information technology beyond school

By the end of key stage 2 pupils should be taught to:

- Design and write programs that accomplish specific goals, including controlling or simulating physical system; solve problems by decomposing then into smaller pars
- Use sequence, selection and repetition in programs; work with variables and various forms of input and output; generate appropriate inputs and predicted outputs to test programs.
- Use logical reasoning to explain how a simple algorithm works and to detect and correct errors in algorithms and programs.
- Understand computer networks including the internet; how they can provide multiple services, such as the world-wide web; and the opportunities they offer for communication and collaboration.
- Describe how internet search engines find and store data; use search engines effectively; be
 discerning in evaluating digital content; respect individuals and intellectual property; use
 technology responsibly, securely and safely.
- Select, use and combine a variety of software (including internet services) on a range of digital devices to accomplish given goals, including collecting, analysing, evaluating and presenting data and information.

Resources and access

The school acknowledges the need to continually maintain, update and develop its resources and to make progress towards a consistent, compatible system by investing in resources that will effectively deliver the strands of the national curriculum and support the use of computing across the school. Teachers are required to inform the ICT co-ordinator of any faults as soon as they are noticed. Resources, if not classroom based, are located in the computer areas or stored away by the ICT co-ordinator. A service level agreement with Gateshead, is currently in place to help support the co-ordinator to fulfil her role both in hardware audio visual.

Planning

We provide a bespoke curriculum designed to meet and respond to the changing needs of our pupils. Primary Computing, Teach Computing and Purple Mash are just some of the schemes used to support the structure of our curriculum along with programme created in response to pupil discussions and current technological advances.

Assessment and record keeping

Teachers regularly assess capability through observations and looking at completed work. Key objectives to be assessed are taken from the national curriculum to assess key computing skills each term. Assessing ICT and computing work is an integral part of teaching and learning and central to good practice. As assessment is part of the learning process it is essential that pupils are closely involved. Assessment can be broken down into:

- Formative assessments which are carried out during and following short focused tasks and activities. They provide pupils and teaching staff the opportunity to reflect on their learning in the context of the agreed success criteria. This feeds into planning for the next lesson or activity.
- Non negotiable assessment should review pupils' capability and provide a best fit. Use of
 independent open-ended tasks, provide opportunities for pupils to demonstrate capability in
 relation to the term's work. Non negotiable assessment should be recorded for all pupils –
 showing whether the pupils are developing, working as expected or secure in the learning
 objectives.

We record the results in an assessment file. Computing work is saved on the school network and/or in pupils' files.

Monitoring and evaluation

The subject leader is responsible for monitoring the standard of the children's work and the quality of teaching. The subject leader is also responsible for supporting colleagues in the teaching of computing, for being informed about current developments in the subject, and for providing a strategic lead and direction for the subject in the school. The governors will ensure this policy is reviewed.

Equal opportunities

We will ensure that all children are provided with the sane learning opportunities whatever their social class, gender, culture, race, disability or learning difficulties. As a result, we hope to enable all children to develop positive attitudes towards others. All pupils have equal access to ICT and computing and all staff members follow the equal opportunities policy.

Health and safety

The school is aware to the health and safety issues involved I children's use of ICT and computing.

- All fixed electrical appliances in school are tested be a LA contractor every five years and all
 portable electrical equipment in school is tested by an external contractor every twelve
 months. It is advised that staff should not bring their own electrical equipment into school but
 if this is necessary, then the equipment's must be PST tested before being used in school.
- Damaged equipment should be reported to the co-ordinator who will arrange for repair or disposal.
- Children should not put plugs into sockets or switch the sockets on.
- Trailing leads should be made safe behind the equipment.
- Liquids must not be taken near the computers.
- E-safety forms and integral part of the curriculum and the school will deliver further education through online safety lessons at the beginning of the school year. Reminders will be issued throughout the year.

Security

- Anti-virus software is updated by Gateshead SLA.
- Use of ICT and computing will be in line with the school's 'acceptable use policy'. All staff, volunteers and children must sign a copy of the schools AUP.
- Parents will be made aware of the 'acceptable use policy' at school entry.
- All curriculum computers have Impero forensic software installed, which alerts the Head Teacher and co-ordinator of any misuse or inappropriate captures.
- All pupils will be aware of the school rules for responsible use on logging to the network and will understand the consequence of any misuse.
- The agreed rules for safe and responsible use of ICT and computing and the internet will be displayed in the ICT and computing area.
